- Pathways; James attended a meeting with the MoE and others regarding looking at ways of keeping the talented NZer's in NZ especially ICT trained.

## 5. Correspondence

MoE – Satellite Unit

A meeting was held between ourselves, Orewa College, Wentworth College, Kingsway School, and the Ministry to discuss the ORS provision in the Hibiscus Coast. As a result the Ministry have requested that we host a Satellite Unit of either Wilson School or Wairua Valley Special School. After consideration the Board have asked James to proceed carefully and to keep them fully informed of progress.

Initial points to be considered:

- What is the role of the Whangaparaoa College BoT with the Satellite?
- Assurance that no existing buildings be used for the Satellite.
- That there be zero resourcing issues for the College.

## 5. Principal's Report

#### Roll 2016

Our roll has already surpassed the Ministries estimation. There could be a challenge regarding the Yr 7 level due to learner numbers. Currently we are staffing 7 Yr 7 classes, but increased enrolment suggest there needs to be an additional Yr 7 class.

## Enrolment Scheme

The proposed Home Zone the Ministry has outlined consists of; Starting at the Orewa Bridge, travel south and west along the centre of the Hibiscus Coast Highway (65 -253 odd numbers only included) to the intersection with Whangaparaoa Road (included). Travel cross country to the Weiti River, travel east along the river towards Karapiro Bay and follow the coastline of the entire Whangaparaoa Peninsula north east, then west, back to the starting point.

Questions arising from this;

- Do we get property funding for all learners if we abandon the zone?
- How many of our learners are currently out of zone?
- Is the funding back-dated for the learners who are currently out of zone but would fall into the Home Zone if adopted?
- Can we push for the Home Zone to be extended to the Hibiscus Coast Highway in the future if we accept the Home Zone now?

It was agreed that James would proceed and meet with the Ministry to discuss and go through the process, to increase our zone out to the Hibiscus Coast Highway.

## CoS

With the official approval from the Ministry to form a Community of Schools with Stanmore Bay, Whangaparaoa Primary and Gulf Harbour the process begins. This will require one of the Principals' to take on the Leadership Role (James has stated that he will not put himself forward for this role). Of the remaining Principals there is interest from one to look at taking on this position. It will be well into 2016 before this gets underway. The expectation is that there will be greater shared information regarding learners and consistency of teaching amongst the contributing schools. Also the sharing of resources and lead teachers. The outcome will be positive for all learners.
