# 8. Principal's Report

Staffing

James talked briefly about the New Zealand wide shortage of teaching staff, but more significantly the Auckland wide shortage. He is in agreement with other Auckland principals that it is hard to attract staff to the Auckland area. However, at Whangaparaoa we are receiving more applicants on average compared to other Auckland schools. Nevertheless we should not be complacent as we are still in the Auckland area, which is expensive to live in. To help with the substantial smaller number of teachers in New Zealand/Auckland the principals would like the MoE to fund a group to travel overseas to 'Talent Fairs' on a recruitment drive for more teachers.

There are several teachers leaving this year, most are moving out of Auckland for family or other reasons. At present we have two positions at the interview stage, and two that are currently advertised.

James thanked the Personnel Committee, especially Heidi for their time and effort around the appointment process for the new Deputy Principal. We were lucky to receive a high calibre of applicants. James reported that Dawn Sullivan has been appointed Deputy Principal. Dawn comes from being Head of Science at Kristin School. She has already attended SLT meetings, meet most of the staff at the End of Year Staff function, and is keen to get started.

Annual Plan

James handed out a 'draft Annual Plan', with anticipation that it will be adopted formally at the first meeting in 2017. More input to come from staff around their expectation of the goals percentages. Once the document has been approved it will be in every classroom, and on the College web-site.

Questions arising;

How is the evidence going to be reported?

It was decided that it should be reported on each term. This will be through the Middle Management, HoL's, Deans, AC's. James will feed through to the Board. Is there a sense of priority due to the way they are listed?

No - all Focus Areas are equal.

**Enrolments** 

Are going strong, information coming from our contributing schools with names of who they believe will be enrolling at Whangaparaoa College. We also have the largest number of International Students enrolled for 2017.

Community of Learning

Stephen reported an appointments panel for the CoL met and they have appointed Lisa White as the Lead of the Whangaparaoa Community of Learning, this appointment is for a year.

## 9. Finance Report

It was asked if the consultancy fee for PCG Byran Perrow Consulting, is a regular payment? It was explained that PCG are used when there are big property developments happening, therefore the payments are relative to that. James clarified that the increase in the surplus is due to there being more International learners staying over the summer break. This prompted questions regarding how we gather information around academic achievement of the Internationals. When they return to their homeland how has their education in NZ compared with their peers in their country? Are we adding value? Information is gathered from Agents, and learners themselves, however, getting information from homestay families would also be useful. James/Jason also gather information when they visit agents/schools. One of the biggest challenges with the increase of International learners is finding Homestay families.
