3. Ratification of Grant requests presented at March Strategic Meeting Motions:

"The Whangaparaoa College Board of Trustees supports the Whangaparaoa College application to **Auckland Council, Hibiscus and Bays Local Board Community Funding** for a contribution of funds towards the ongoing site maintenance costs associated with our College Wetlands Area Project up to the value of \$10,000.00."

5. Work in Progress

James reported that Steve Watts interviewed every Yr 13 learner, asking the following questions:

- 1. How have you found the step up from Level 2 to Level 3?
- 2. What is the criteria for achieving Level 3 NCEA and University Entrance?
- 3. Of the subjects you take that are on the Approved List, rank the subjects in order of your confidence in gaining credits.
- 4. What do you intend to do next year?

Majority of learners acknowledged there was a greater workload, and those taking what would be considered more demanding academic subjects in general acknowledged that the level of work was more challenging.

Most could correctly identify the criteria required for achieving Level 3 NCEA and UE. 75% of the learners intend to undertake some type of Tertiary study, 10% were unsure, 9% will undertake an apprenticeship or employment and 8% are looking at a Gap year before study.

Heidi would be keen for the Careers department to present to the Board. Currently Year 13 leaners have talks from Auckland, Massey, Victoria, and Otago University's, AUT, UniTec, Combine Trades and the Forces.

How well do we prepare our learners for university? Should universities look at how they are preparing themselves to receive learners from schools? James commented that the Vice Chancellor from Auckland University wants to talk to principals about how the university can be better prepared for the modern learner. Where to from here? – Subject teachers will identify those who they believe will not achieve 14 credits in their subject and support will be established.

7. Principal's Report

New Staff

Discussion had around possible direction the MoE was heading around CoL's, and noted that Whangaparaoa College would like to be seen as a lead school.

Special Needs Satellite Unit

With the growing number of special needs children in our area the MoE are exploring the viability of a satellite of the Waiaru Valley Special School at Whangaparaoa College. James and Ginny Catterall met with members for Waiaru Valley Special School, MoE and their architects. It was proposed by the MoE that existing buildings could be used for the satellite. This was firmly rejected by both Whangaparaoa College and the Waiaru Valley Special School. A feasibility study will be conducted with several proposals to be considered. *Charter*

15. General Business

Heidi suggested a future discussion at a Strategic Meeting to be around the role the school has, if any, in educating learners about issues around consent, and if we do believe school has a role to play, what should it be? This was raised in light of the issues around consent (in particular when students have been drinking) that cropped up at Wellington College earlier in the year. There was a march on parliament that highlighted students think there is an emerging culture around this that needs to change. There have been several similar sorts of incidents at various secondary schools in the last 2 years e.g. the roast busters case. What do we as a school currently do? She suggested that if we did think it was appropriate for school to provide some guidance to learners, it could be done in the broader context of respect (one of our values) and also link in social media and other issues that might also fall under the respect banner.
